### **ACCEPTANCE OF TERMS.**

#### SUBSCRIPTION GRANTED.

User names are not transferrable. Purchasers can add additional users for a fee. Additional users can only be added in the year that the full-package purchase was made. Subscription for all users is per edition (which is six months from transaction date). On termination of the subscription granted in this agreement, users will cease and desist from all use of Courses and the Course Materials.

For individual module purchases, ICE grants a non-exclusive, non-transferable subscription of one user name and login per purchase. User names are not transferrable. Additional users cannot be purchased for individual modules. Subscription for user is per edition (which is six months from transaction date).
